Who: Open to any wrestler entering their freshman, sophomore, junior or senior year of High School. No High School Graduates! Females are welcome to come and encouraged to come, we will pair girl only matches.

What: The league consists of individual wrestlers; no team scores will be kept. Coaches may bring 1 wrestler or your entire team. We plan on weighing in each night and we will make pairings from wrestlers in attendance that night.

Where: Schuyler High School Wrestling room, Please park on the South side of the building. Signs will be posted for where to enter. Enter Door **12 C** Go up the stairs into the wrestling room.

When: Tuesdays, May 30, June 13, 20 Running 3 full mats.

Goal: Each wrestler that weighs in will get 2 matches. Wrestlers may wrestle an additional exhibition match if they choose to, at the end of the paired matches.

Other Information: Wrestlers need to have a coach or adult representative present in case of an injury.

If a wrestler can't make it to most of the nights but would like to come to 1 or 2 nights, they can walk in and pay, (\$10 per night) and they must have a signed waiver form to be able to wrestle. (NO FORM- NO WRESTLE)

All Wrestlers that sign up for the 3 weeks will receive a T-Shirt. They will also receive the discount of (\$35 Dollars for all 4 nights) If a wrestler just decides to pay as he/she goes, he/she will **not** receive a T-Shirt.
